6. Planning and Tree Works Applications:
15/06446/FUL - 8 Squarey Close, Downton - Raise roof of existing side extension and install side dormers.
14/06561/FUL - Charles Church - for Land to the West of Salisbury Road, Downton, Wiltshire - Erect 99 dwellings (79 houses and 20 flats) together with garages, timber pergolas, garden sheds and refuse/cycle stores and associated works – To consider a recommended response from the New Housing Development Committee to the amended plans and a final response to the application.
7. In relation to the Parish Council's powers under Section 19 of the Local Government (Miscellaneous Provisions) Act 1976, to consider a proposal from Cllr Mace to approve a grant of £1,000 to the Brian Whitehead Sports Centre Association as a contribution towards its project to replace the lights in the indoor Sports Hall and Tennis Hall. The total cost will be £28,818 and the replacement lights will be more efficient and of longer life as well as being more environmentally friendly. This to be done by viring £400 from this year's 'Odd Job Contractor' budget line and taking £600 from reserves.
