145/23 Public Question Time

Dog Poo Bins

Dog Poo Bins

The Parish Council are now aware of this bin and recognise it was missed off the list provided to Idverde. The Parish Council must make a decision on how appropriate it would be to keep this bin as it's on private land.

Play Park Refurbishment

Extensive public consultation took place in 2021 (public meetings, questionnaires, focus groups at both schools). The results of which led to the production of the Tender Brief issued to three selected suppliers in June 2023. The Parish Council has discussed all bids (and designs) received in meetings closed to members of the public due to the highly confidential (commercially sensitive) nature of the discussions.

Tonight, the Parish Council are finalising the contract and T&Cs and discussing the Comms Plan (Agenda 151/23 – closed to members of the public due to the highly confidential (commercially sensitive) nature of the discussions)

JB confirmed full consideration has been given to the Memorial Gardens being sited in the conservation area.
